





Sr. No	Recommendation by IQAC	Action taken and Outcome
1.	To strengthen activities to be conducted as part of Priyadarshini Yuvati Manch, Electoral Literacy Club, Skill Development, Entrepreneurship Development Cell, professional development of teachers etc.	The college conducted awareness sessions on entrepreneurship through the Entrepreneurship Development Cell to make the participants aware of the process and avenues available. The sessions focused on the orientation on two key aspects 1) innovation and 2) business plan. Members also agreed to strengthen the student forum by establishing a platform for the outstation students to communicate their concerns. All Departmental Heads agreed to orient students for the two aspects.
2.	AICTE approved academic programs as per university nomenclature for BBA / BBA-IB / BBA-CA as Department of Management	The college has three academic programs approved by AICTE which previously were under the Faculty of Commerce, SPPU and currently under the Faculty of Management. These programs have now been proposed to be aligned together to ensure the statutory body guidelines. An AICTE officer at the college to be appointed for ensuring compliance.
3.	To publish a biannual peer reviewed journal for promoting multidisciplinary research.	The college is in process of publishing a biannual peer reviewed journal and has invited eminent national and international researchers as board members. The request for the ISSN number has also been submitted to the National Science Library.
4.	To organize Annual Quality Assurance Report Camp and Academic Performance Indicator Camp	The college successfully organized the API Camp as per the affiliating university revised API Form and communicated the report of the camp to the university. The AQAR Camp was also successfully organized by the



		Academic and administrative audit committee along with the MIS committee.
5.	To introduce academic programs under School of Open & Distance Learning	The college has submitted a proposal for introducing academic programs under School of Open & Distance Learning as per NAAC recommendation 1 of Peer Team Report January 2025 and will be conducting the said academic programs on the proposal approval.
6.	To ensure awareness with the upcoming NAAC revised guidelines through FDP / workshops etc.	The college proposed the organization of an awareness session for all staff for orienting them for the revised guidelines by NAAC for Maturity-Based Graded Level Accreditation (MBGL) and aligning with the guidelines.
7.	To organize alumni meet and seek contributions from alumni for campus development.	As is the regular practice, an alumni Meet was proposed to be conducted in the next academic year and seek contributions to strengthen the academic facilities in the new building for the benefit of students in providing state of the art academic infrastructure.
