- **Iron tablets, required medicines and nutritional supplements** are distributed to anemic students.
- Nutritional supplements are also provided with the support and generous contribution of faculty members and students.

This initiative reflects the College's commitment to preventive healthcare, early diagnosis, and holistic wellbeing of students by ensuring timely medical attention, counselling and nutritional support.
